Our charitable mission is educating and empowering people to utilize Assistance Dogs to transform their lives.

We work to exceed industry training and utilization standards for all of our Assistance (Service) Dogs, and to increase the public's knowledge about the important roles these Dogs serve within society.

We specialize in training customized Assistance (Service) Dogs for two general groups: children and adolescents with physical, neurological, psychiatric, or emotional disabilities; and Veterans and Service Members with Chronic/Complex Post-Traumatic Stress Disorder (C-PTSD), Traumatic Brain Injuries (TBI), and Military Sexual Trauma.
